Decree of the President of the Republic of Azerbaijan "On some measures to improve public administration in the Republic of Azerbaijan"

Governed by Clause 32 of Article 109 of the Constitution of the Republic of Azerbaijan I hereby **resolve** as follows:

- 1. To establish the 'State Agency for Housing Construction under the President of the Republic of Azerbaijan' as a legal entity of public law on the basis of the State Agency for Housing Construction under the President of the Republic of Azerbaijan having the legal status of a 'Central Executive Power Body'.
- 2. To establish the 'Copyright Agency of the Republic of Azerbaijan' as a legal entity of public law on the basis of the Copyright Agency of the Republic of Azerbaijan having the legal status of a state body considered equal to the status of the 'Central Executive Power Body'.
- 3. To establish the 'State Agency for Alternative and Renewable Energy Sources of the Republic of Azerbaijan under the Ministry of Energy of the Republic of Azerbaijan' as a legal entity of public law on the basis of the State Agency for Alternative and Renewable Energy Sources having the legal status of a state body considered equal to the status of the 'Central Executive Power Body'.
- 4. To establish the 'Azerbaijan State Information Agency (AZERTAC)' as a legal entity of public law on the basis of the Azerbaijan State Information Agency (AZERTAC) having the legal status of a 'State Body'.
- 5. To establish the 'Icherisheher' (Old City) State Historical-Architectural Reserve Office' a legal entity of public law on the basis of the 'Icherisheher' State Historical-Architectural Reserve Office under the Cabinet of Ministers of the Republic of Azerbaijan having the legal status of an 'Executive Authority Body'.
- 6. To establish the 'Seaside Boulevard Department' as a legal entity of public law on the basis of the Seaside Boulevard Department under the Cabinet of Ministers of the Republic of Azerbaijan having the legal status of an 'Executive Authority Body'.
- 7. To establish the 'Baku Transport Agency' as a legal entity of public law on the basis of the Baku Transport Agency under the Cabinet of Ministers of the Republic of Azerbaijan having the legal status of an 'Executive Authority Body'.
- 8. To establish the 'State Agency for Compulsory Medical Insurance' as a legal entity of public law on the basis of the State Agency for Compulsory Medical Insurance under the Cabinet of Ministers of the Republic of Azerbaijan having the legal status of an 'Executive Authority Body'.
- 9. To establish the 'Azerbaijan State Translation Center' as a legal entity of public law on the basis of the Translation Center under the Cabinet of Ministers of the Republic of Azerbaijan having the status of an 'Executive Authority Body'.
- 10. To place the State Courier Service under the Cabinet of Ministers of the Republic of Azerbaijan under the Special State Protection Service of the Azerbaijan Republic and hand over its authorities to the Special State Protection Service of the Republic of Azerbaijan.

- 11. Transfer the state property owned by the State Courier Service under the Cabinet of Ministers of the Republic of Azerbaijan to the Special State Protection Service of the Republic of Azerbaijan.
- 11-1 The President of the Republic of Azerbaijan appoints and dismisses Heads (Board Chairmen) (including heads of management bodies) of the public legal entities created in accordance with Paragraphs 1-9 of this Decree.
 - 12. The Cabinet of Ministers of the Republic of Azerbaijan shall:
- 12.1. Prepare within a period of two months draft Regulations of the legal entities of public law created in accordance with Paragraphs 1-9 of this Decree and submit them to the President of the Republic of Azerbaijan;
- 12.2. Prepare proposals within a period of two months in relation to constitutors of the legal entities of public law created in accordance with Paragraphs 1-9 of this Decree and submit them to the President of the Republic of Azerbaijan;
- 12.3. Prepare within a period of two months and submit to the President of the Republic of Azerbaijan proposals on aligning legal acts of the President of the Republic of Azerbaijan with this Decree;
- 12.4. Ensure within a period of two months and inform the President of the Republic of Azerbaijan about alignment of regulatory acts of the Cabinet of Ministers of the Republic of Azerbaijan with this Decree;
- 12.5. Exercise control over the alignment of regulatory acts of bodies of central executive authority with this Decree and inform the President of the Republic of Azerbaijan about its execution within a period of two months;
 - 12.6. Resolve all other issues arising from the Decree.
- 13. The Executive Authority Bodies stated in Paragraphs 1-9 of this Decree are to continue their work until the legal entities of public law created in accordance with Paragraphs 1-9 of this Decree are registered in accordance with the Law of the Republic of Azerbaijan "On State Registration and State Registry of Legal Entities".
- 14. The Ministry of Justice of the Republic of Azerbaijan shall ensure the alignment of regulatory acts of central executive bodies with this Decree and inform the Cabinet of Ministers of the Republic of Azerbaijan.
